

## **WARNINGS FOR BED SAFETY**

- a) There is a risk of entrapment associated with all bed rails. Entrapment occurs when an individual becomes caught, wedged or entangled in the gaps in or about the bed rail, mattress or bed frame. Entrapment can result in serious injury and death. Read and understand the included WARNINGS FOR BED SAFETY, ENTRAPMENT PREVENTION GUIDELINES, SOFT MATTRESS WARNING and ASSEMBLY INSTRUCTIONS prior to beginning assembly, installation, and use of product. This product can only be used on beds and mattresses that comply with the specifications set forth in the included WARNINGS FOR BED SAFETY, ENTRAPMENT PREVENTION GUIDELINES, SOFT MATTRESS WARNING and ASSEMBLY INSTRUCTIONS. - d) This product is for adult use only and is intended to assist disabled persons by providing minimal to moderate weight support while standing from bed. This product is NEVER to be used as a device to restrain individuals from getting into and out of bed.
- e) This product is equipped with a Safety Strap or Screws that securely attaches the product to a bed frame. NEVER use this product without securely attaching it to bed frame. Failure to properly secure product to bed frame with Safety Strap or Screws significantly increases the risk of entrapment, and may result in personal injury or death. NEVER remove or use the product without Safety Strap or Screws.
- f) NEVER use unless product is tight against mattress, without gaps and safety strap has no slack. A gap between product and mattress means the product was installed improperly. STOP using product immediately if a gap is noticed between the side of the mattress and the product. STOP using product immediately if product is damaged, broken, or if parts are missing. STOP using product immediately if product shifts out of its original position until it is readjusted into the correct position.
- g) NEVER use multiple bed rails on the same side of the bed.
- h) If this product is used in a nursing home, assisted living center, or a similar facility, follow these instructions and all of the facility's Bed Rail/Handle policies. DO NOT install or use this product if it does not comply with the facility's policies.
- i) If product is removed from bed, DO NOT reinstall until you have read and fully understand the included WARNINGS FOR BED SAFETY, ENTRAPMENT PREVENTION GUIDELINES, SOFT MATTRESS WARNING and ASSEMBLY INSTRUCTIONS.
- j) ALWAYS position the product at least 12.5 inches from the head of the bed and the foot of the bed, as shown in FIGURE A. ALWAYS ensure that the top of bed rail is a minimum of 4 inches (10.2cm) above top surface of mattress, as shown in FIGURE A. Incorrect placement increases the risk of entrapment, serious injury, or death.
- k) ALWAYS secure and maintain the product tight against the mattress with no gap between the product and the mattress, as shown in FIGURE B. When properly installed there is no gap between the product and the mattress. A gap indicates improper installation. If a gap is present, STOP using immediately and re-install correctly.
- l) WARNING: If the safety strap provided is not properly secured, the product may move into an unsafe position which increases the danger of entrapment. See included ASSEMBLY INSTRUCTIONS for proper use of the straps.
- m) You must measure your mattress and confirm that it is between 10 inches – 12 inches thick. NEVER use unless your mattress is between 10 inches – 12 inches thick. Using a mattress that does not fall within this thickness range increases the risk of entrapment, serious injury, or death.



## WARNINGS FOR BED SAFETY

### **⚠ WARNING ENTRAPMENT, STRANGULATION, SUFFOCATION AND FALL HAZARD**


This product is NEVER to be used by people with Alzheimer's disease, dementia, restlessness, or those who are sedated, confused or frail. Gaps in and around this product can entrap and kill. People with Alzheimer's disease or dementia, or those who are sedated, confused, or frail, are at increased risk of entrapment and strangulation. People attempting to climb over this product are at increased risk of injury or death from falls. Always make sure this product is properly secured to bed. If product can move away from bed or mattress, it can lead to entrapment and death.

### **⚠ WARNING SUFFOCATION, STRANGULATION, ENTRAPMENT HAZARD**

If product is installed incorrectly or moves from its initial position, gaps can occur which can entrap and kill. People with Alzheimer's disease, dementia or other neurological conditions, or those who are sedated, confused, or frail, are at increased risk of entrapment, suffocation, and strangulation.

- NEVER use unless product is tight against mattress, without gaps, and at least 12 ½" (32cm) from headboard and footboard.
- NEVER use with children.
- NEVER use on toddler, bunk, water, or inflatable beds or on beds with mattress toppers or soft compressible pads.

### ENTRAPMENT PREVENTION GUIDELINES



### ENTRAPMENT ZONES

**Zone 1: Within the Rail** – The FDA states any open space between the perimeters of the rail greater than 4.75 inches (12cm) poses a risk of head entrapment. This space is less than 4.75 inches (12cm) on all Stander bed rails.

**Zone 2: Under the Rail** – A gap between the bottom of the bed rail and the top of the mattress poses a risk of entrapment. Prevent this risk by adhering to included WARNINGS FOR BED SAFETY and ASSEMBLY INSTRUCTIONS.

**Zone 3: Between the Rail and the Mattress** - A gap between the inside surface of the bed rail and the mattress poses a risk of entrapment. Prevent this risk by adhering to included WARNINGS FOR BED SAFETY and ASSEMBLY INSTRUCTIONS.

**Zone 4: Under the Rail at the Ends of the Rail** - A gap between the mattress and the lowermost portion of the bed rail poses a risk of entrapment. Prevent this risk by adhering to included WARNINGS FOR BED SAFETY and ASSEMBLY INSTRUCTIONS.

**Zone 5: Between Two Bed Rails** - When multiple bed rails are used on the same side of the bed, the space between the bed rails poses a risk of entrapment. Prevent this risk by NEVER using multiple bed rails on the same side of the bed.

**Zone 6: Between the End of the Rail and the Side Edge of the Head or Foot Board** - A gap of less than 12.5 inches (32cm) between the end of the bed rail and the side edge of the headboard or footboard poses a risk of entrapment. Prevent this risk and maintain a gap greater than 12.5 inches (32cm) by adhering to included WARNINGS FOR BED SAFETY and ASSEMBLY INSTRUCTIONS.


**Zone 7: Between the Head or Foot Board and the End of the Mattress** – A gap that is too large between the inside surface of the headboard or footboard and the end of the mattress increases the risk of head entrapment, which can lead to serious injury or death.

## SOFT MATTRESS WARNING

**THERE IS A MUCH GREATER RISK OF ENTRAPMENT AND SERIOUS INJURY/DEATH WHEN USING BED RAILS WITH A SOFT MATTRESS!** A soft mattress increases the risk that a person's head, arm, or leg could become entrapped between the mattress and a rail. Entrapment can cause injury or death.

To ensure it is safe to use this product, test your mattress **BEFORE ASSEMBLY AND INSTALLATION** by applying **12lbs (5.4kg)** of force to a **4 inch x 4 inch (10.16cm x 10.16cm)** area immediately adjacent to the edge of the mattress next to where the product is to be installed. If the mattress compresses more than **2 inches (5.1cm)** when applying **12lbs (5.4kg)** of weight to a **4 inch x 4 inch (10.16cm x 10.16cm)** area, **DO NOT USE THE PRODUCT without also installing the Bed Rail Safety Guard (item #2400/ #2450 sold separately)**. The Bed Rail Safety Guard is designed to minimize the risk of entrapment. If you are unsure, install the Bed Rail Safety Guard **(item #2400/ #2450 sold separately)**




- Non-adjustable bed use: Use **ONLY** on a bed with a bed frame that the SAFETY STRAP can attach to, per ASSEMBLY INSTRUCTIONS.
- Adjustable bed use: Use **ONLY** on adjustable beds with wood platforms, using included SCREWS per ASSEMBLY INSTRUCTIONS.

**Cleaning:** Clean product with warm water and soap. Dry thoroughly before using.



1. Remove product from box and identify all parts as shown in *FIGURE 1*.




2. Determine correct configuration: Adjustable or Non-adjustable bed. See *FIGURE 2*.


### Adjustable Wood Platform Bed Assembly and Installation

3. Remove safety straps from Legs **A** and **B** using tools provided (**J** and **R**). Remove red grippers from both legs using a Flat Head Screwdriver as shown in *FIGURE 3*.





4. Partially thread Bolt **N** into **Lower** holes in Bracket **C**, as shown in *FIGURE 4*. Do not thread too far – bolt should not block assembly of Legs.





5. Insert Leg **A** into Bracket **C**. Align the top edge of Bracket **C** with horizontal line on Leg **A**. Align holes on Bracket **C** with the solid vertical line on Leg **A**, as shown in *FIGURE 5*. Screw Bolt **N** through hole and tighten firmly with Tool **J**. Insert Bolt **L** into the **Upper** hole and tighten firmly. Repeat for Leg **B**. Legs should be parallel when assembled.

6. Insert Bolts **P** through Washers **K**, then Bracket **C**, then screw into Receiver **D**. Tighten firmly using Tool **H** as shown in, *FIGURE 6*.




**FIGURE 7A**

7. Attach assembly to Head Section or Mid Section of Bed Frame, as shown in *FIGURE 7A*, using Screws **Q**. Ensure the Bed Rail is tight against the Mattress without gaps.

**⚠ WARNING SUFFOCATION/STRANGULATION/ENTRAPMENT HAZARD**


**NEVER** use unless product is tight against mattress, without gaps. If the Screws are not properly secured, the product may move, which increases the risk of entrapment, serious injury or death.

**NEVER USE PRODUCT UNLESS ALL 6 SCREWS ARE PROPERLY SCREWED TO BED:**

- Both Legs **A** and **B** must be on the same section of the bed.
- Edge of installed Bed Rail **E** must be at least 12.5" from Head of Bed.
- There must be **NO** gap between Bed Rail **E** and Mattress, as shown in *FIGURE 7B*.
- Ensure Screws **Q** will not interfere with any components on underside of Bed Frame.
- Do not overtighten Screws **Q**.


**Non-adjustable Bed Assembly and Installation**

8. Partially thread Bolt **L** into **Upper** holes in Bracket **C**, as shown in *FIGURE 8*. Do not thread too far – bolt should not block assembly of legs.





- Insert Leg **A** into Bracket **C**. Align the top edge of **C** with horizontal line on Leg **A**. Align holes on Bracket **C** with the dashed vertical line on Leg **A**, as shown in *FIGURE 9*. Screw Bolt **N** through hole and tighten firmly with Tool **J**. Insert Bolt **L** into the **Lower** hole and tighten firmly. Repeat for Leg **B**. Legs should be at an angle to one another when assembled.





- Insert Bolts **P** through Washers **K**, then Bracket **C**, then screw into Receiver **D**. Tighten firmly using Tool **H** as shown in, *FIGURE 10*.

11. Secure Safety Guard **F** to Legs **A** and **B** with Bolts **M** (4x) using Tool **J**, as shown in *FIGURE 11*.

12. Place base of product directly under the Mattress and extend the Safety Straps **G** below the Mattress to the opposite side of the Bed. Unbuckle Straps, loop around Bed Frame, re-buckle and tighten both Safety Straps to secure the Bed Rail against the side of the Mattress as shown in *FIGURE 12*. Ensure the Bed Rail is tight against the Mattress without gaps and the Safety Straps have no slack.

**⚠ WARNING SUFFOCATION / STRANGULATION / ENTRAPMENT HAZARD**

**NEVER** use unless product is tight against Mattress, without gaps and Safety Straps have no slack. If the Safety Straps are not properly secured, the product may move, which increases the risk of entrapment, serious injury or death.

**NEVER USE PRODUCT IF NOT PROPERLY STRAPPED TO BED:**

- Edge of installed Bed Rail **E** must be at least 12.5" from Head of Bed.
- There must be **NO** gap between Bed Rail **E** and Mattress.
- There must be **NO** slack in Safety Straps **E** after tightening.




Image shows Safety Strap **G** before tightening.
